- The Board is appointing a hiring committee consisting of Secretary Erickson, Treasurer Popovich, and the District's General Counsel to work with the HR firm to advertise for enterprise directors.
- The Board is transitioning the District back to the enterprise system, as directed by the SDA and the District's TABOR exception. There will be a water enterprise director, a wastewater enterprise director, and a parks and rec director. The District is eliminating the General Manager position effective August 30.

- The District is appointing a tech committee consisting of Secretary Erickson and Director Martin to work with the IT company. Board members need admin rights for their email accounts.
- Because Board has fiduciary responsibilities, Board will appoint two members to supervise each of the enterprise directors, once they are hired. Decisions made tonight underscore that Board is responsible for the District and put the District back in line with the SDA model.
- President Stinson thanks Jerry Jacobson for his service.
- President Stinson speaks to the advantages of an enterprise director system as opposed to a general manager system. General manager can bottleneck information. Enterprise directors system puts enterprise directors on equal footing. Enterprise directors will work as a team in the same way the Board works as a team.
